Dear Parents:

On Monday, June 18, or your child's first day of camp, we will welcome your son or daughter to ANGLEWOOD. We look forward to their arrival confident that they will enjoy their camp experience. We request your attention to the following items:

(1) AS SOON AS POSSIBLE, and BEFORE the first day of camp:

1. Insure that the balance of your tuition payment is sent to the Glenside address as soon as possible. If you would like to pay by credit card, please contact Joyce at the number above to get more info.
2. A signed and completed health examination form.
3. If your child is on a medication that he needs to take during the camp day, a Camp Anglewood Medication Form must also be completed and returned to camp. Please call or go to the website to obtain this form.

(2) On June 18<sup>th</sup>, or your child's first day of camp, please have your camper bring the following:

4. Lunch in a paper bag with the camper's name clearly marked. Lunches are refrigerated and drinks are supplied. No glass bottles are allowed at camp. Every Wednesday please pack hot dogs or hamburgers and rolls for the cookout.
5. Two bathing suits - to be taken home every Friday. Towels will be provided.
6. Water Shoes - for the creek and moving between the cabins & the pool.
7. Sports and fishing equipment (optional). If your child wishes to bring his own fishing rod or other equipment, it must have his name clearly marked on it and he must be responsible for it. **PLEASE MAKE SURE NO FISHING HOOKS ARE BROUGHT TO CAMP**. We supply **DE-BARBED** hooks.
8. Medications, and other such personal items should be clearly labeled and in original containers. These will be given to the nurse. Sunscreen and bug spray are kept in the screenhouse and applied by the staff as directed.

(3) Please have your camper's name on ALL articles of clothing and possessions that he wears or brings to camp.

As always, Anglewood continues to be flexible; if you would like to add extra weeks or use our extended hour services, please contact Joyce.

**Camp Transportation**—If transportation is provided by camp, your child will be picked up between 8:00 and 8:30 a.m. You will receive a letter in early June. Drivers will contact parents the week before camp with specifics. If your child is not to be picked up, kindly notify the driver before 8:00 a.m. or the night before.

**Own Transportation**—For parents who are providing transportation, included in this mailing is a letter with specifics on drop-off and pick-up location and time. This letter will also be available from the website.

**Attendance**—If your child is not attending camp one day, arriving late, or leaving early, please call camp at the latest by 9AM on that day to insure that camp is aware of your schedule.

**Extended Hours**—A letter with specific instructions and guidelines is included with this mailing for those families who have requested extended hours. This letter will also be available from the website.
